MINUTES OF THE FIRST GENERAL BODY MEETING OF ODISHA METALLIFEROUS MINES SAFETY WEEK CELEBRATION COMMITTEE (2019-20) HELD ON 05.07.2019 AT OFFICE OF DIRECTOR OF MINES SAFETY, BHUBANESWAR

- 1.0 The First General Body meeting of OMMSWCC, 2019-20 was held at 11.30AM on 05.07.2019 at the office of Director of Mines Safety, Bhubaneswar Region. List of persons who attended the meeting is enclosed as **Annexure-1** at the end.
- 1.1 Present on the dais: Shri S. Bagchi, Director of Mines Safety of Bhubaneswar Region, Shri I. Satyanarayana, Deputy Director of Mines Safety of Bhubaneswar Region, Representatives from M/s B.C. 2.4 Contribution from Mine Owners and Contractors towards OMMSWCC 2019-20

2.4.1 As approved by the House, the contribution fee from participating mines and Contractors will be the same as in last year which is mentioned below:

Group-A mines	Rs. 50,000/-
Group-B mines	Rs. 45,000/-

Contractor (mine wise)	Rs. 30,000/- for each mine

A Contractor working in more than one mine will have to pay Rs. 30,000/- for each mine separately, e.g. a Contractor working in two different mines will have to pay Rs.60,000/-, a Contractor working in three different mines will have to pay Rs.90,000/- The Agent/Manager of the mine will ensure the payment of the contribution fee by the contractor of his mine.

It is also decided that the expenses will be optimized.
